3. NATIONAL CHAMPIONSHIP

- The sanctioning fees for NATIONAL CHAMPIONSHIP is payable to the Country Committee. For those countries that don't have Representatives, the sanction fees are to be paid to Head Office.
- The ring officials fees to be paid in accordance to the standard country rates where the championship is held.


